

## **PARC Collaborative Conservation Partnership Award**

### **2026 Nomination Announcement**




Figure 1. Map showing active PARC areas.

**About the Award:** This award is presented annually by Partners in Amphibian and Reptile Conservation (PARC) to recognize outstanding multi-organizational Partnerships that conduct work in an active PARC area (Fig. 1) and achieved significant outcomes that support PARC's mission to "forge proactive partnerships to conserve amphibians, reptiles, and the places they live."

A representative of the Partnership will receive a commemorative plaque, and all other members will receive a commemorative certificate. A representative for the Partnership will receive an invitation to present at a regional PARC meeting, with registration and lodging provided by PARC's Joint National Steering Committee (JNSC). The representative that receives the plaque and attends a regional meeting will be selected by members of the Partnership.

# **Eligibility:**

A Partnership eligible for this award shall minimally comprise three or more individuals representing three or more organizations (e.g., agencies, NGO, universities, industries, etc.) or three or more distinct teams or workgroups within larger organizations (e.g., agency workgroup, university laboratory). Established groups/teams that comprise members from three or more organizations may also be directly nominated.

Partnerships that include one or more members of the PARC Joint National Steering Committee (Table 1) within a nominated team are eligible for this award, as long as they are not the PI, team leader, or team representative. JNSC members that are members of a nominated Partnership, are expected to recuse themselves from voting for an award winner. JNSC members are not eligible for meeting registration or lodging reimbursements if presenting on behalf of the Partnership.

Nominations may be submitted for others, or self-submitted, and must meet **two or more** of the following criteria.

#### Award Criteria:

Any long- or short-term Partnership that has achieved significant conservation outcomes for herpetofauna and has displayed exemplary commitment to building or strengthening amphibian and reptile conservation through at least **two** of the following:

- 1. A broad representation of individuals or organizations across sectors, disciplines, or backgrounds.
- 2. Prioritizing the inclusion of under-represented groups in the field of conservation (i.e., marginalized groups or sectors of society).
- 3. Inclusion of non-traditional partners in the field of conservation (e.g. industries, businesses, or private sector partners that pro-actively incorporate practices to conserve amphibians, reptiles, and their habitats, or promote efficiencies in herpetofaunal conservation).
- 4. Inclusion and application of traditional ecological knowledge to conservation of amphibians, reptiles, and their habitats.
- 5. Exhibited tenacious effort, leadership and professionalism in a manner that is inspiring to their peers and the conservation community at large, and has been overlooked by other means of acclaim, or who has made a significant achievement with limited resources.

PARC is dedicated to promoting inclusivity and collaboration as core values, with a strategic focus on improving equity within the herpetofaunal conservation community. We strive to create diverse and inclusive environments and networks for those involved in herpetofaunal conservation. In addition to achieving significant outcomes for conservation, nominees must align with these values. The nomination packet includes a statement regarding the Partnership's contributions to increase diversity and advance inclusion of under-represented groups of people in herpetofaunal conservation.

Nominated Partnerships must observe and uphold the highest standards of scientific integrity and professional behavior, and must uphold <u>PARC's Code of Ethics and Meeting Code of Conduct</u>.

Nominations received after this date and incomplete forms will not be considered. The award winner will be notified by Spring 2026.

## **Selection Process:**

PARC JNSC members (Table 1.) will review nominations, evaluate carefully against the criteria, and vote to determine the selection. JNSC members who are part of a partnership effort shall recuse themselves from voting. JNSC's Senior Co-Chair will notify the award recipient and their nominators once a vote is finalized.
